SUBJECT: State Fiscal Recovery Fund, Continuity of Operations Quarterly Report

Per Session Law 2021-180, Section 4.13, the Office of State Budget and Management (OSBM) is required to submit a report to the Joint Legislative Commission on Governmental Operations regarding the allocation of federal American Rescue Plan Act (ARPA) State Fiscal Recovery Funds (SFRF) used for Continuity of Operations (COOP). Currently, OSBM and the North Carolina Pandemic Recovery Office (NC PRO) are working to review and approve requests from state agencies and other organizations for current and anticipated COVID-19 recovery related expenses through December 31, 2026.

Specifically, the Session Law appropriates \$25,335,471 of ARPA SFRF funds to OSBM for COOP related expenses. As of November 30, 2022, OSBM has authorized \$19,979,912 and disbursed \$3,690,700.

Authorizations with disbursements include:

- \$500,000 Industrial Commission operations all funds requested and disbursed
- \$750,000 NC Independent Colleges and Universities State Longitudinal Data System \$100,000 requested and disbursed
- \$1,251,323 Department of Natural and Cultural Resources NC Student Connect (Park and Learn) Project \$440,000 requested and disbursed
- \$562,500 Office of State Human Resources Cornerstone contract all funds requested and disbursed
- \$409,094 United Way of North Carolina NC 211 System Operations \$88,200 requested and disbursed
- \$2,000,000 Department of Administration RETOOL NC grant program funding all funds requested and disbursed

Authorizations not yet disbursed:

- \$1,500,000 State Board of Elections operating expenses
- \$1,200,000 Secretary of State Remote Online Notary
- \$1,000,000 Department of Natural & Cultural Resources NC PUSH (Priority Updates to State History)
- \$200,000 Department of Commerce 2023 Navy Federal Credit Union Stadium Series
- \$6,995 Seven Tribes calculation error in Session Law 2021-189

Authorizations for on-going administration, monitoring and auditing of ARPA funds needed to ensure proper use of funds through the end of the expenditure period, December 31, 2026, include:

- \$6,000,000 for ARPA grants management through 2026
- \$4,000,000 for state agency administration, monitoring and auditing through 2026
- \$600,000 for Office of State Budget and Management (OSBM) Federal Funds Manager (time-limited staff)
